The defendant was convicted of involuntary manslaughter and sentenced to serve four months in the State Penitentiary. He was charged with driving an automobile with his wife as a passenger while he was under the influence of intoxicating liquors and was guilty of a violation of the Georgia law prohibiting that. A witness for the State, who was called to testify as to the sobriety of the defendant's wife at the time of the occurrence, was asked whether at that time the defendant had consumed anything. He was first asked whether, while she was not at the police station, the defendant or anyone else had given her anything to drink at that time. The witness objected to this question on the ground that the State had not established the legality of the arrest of the defendant's wife. This objection was sustained. The witness was then asked whether the defendant had given his wife a beverage, to which he answered affirmatively. At this time the defendant's attorney objected on the ground that this was a violation of the defendant's right to remain silent. It was this objection which was overruled, and this ruling is assigned as error. The State, in its argument, concedes that the arrest of the defendant's wife and the taking of her to the police station violated her constitutional right to *823 be free from unreasonable search and seizure. In that connection, the State argues that the witness was not entitled to testify as to whether the defendant gave his wife a drink since she had not been charged with 595f342e71
